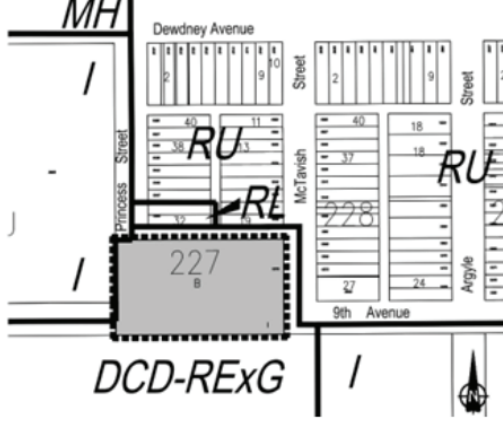

PUBLIC NOTICE ZONING BYLAW AMENDMENTS

Regina City Council intends to consider the following housekeeping and administrative amendments to *The Regina Zoning Bylaw, 2019*.

1. Zoning Bylaw text amendments:
This includes general corrections, improving clarity and increasing flexibility in the regulations.
2. Zoning designation amendment:
Rezoning of a property located at 1570 McTavish Street (legally described as Plan DV4404, Block 227, Lot B) from PS – Public Service Zone to DCD-RExG – Regina Exhibition Grounds Direct Control District as illustrated in the following map.



REASON:

1. The Zoning Bylaw text amendments are administrative in nature and intend to keep the regulation free from typographical errors, incorrect references, or other discrepancies. These amendments are required to clarify the intent of regulations or make it easier for Zoning Bylaw users to understand and better align with the City's *Official Community Plan* and Strategic Priorities.
2. The zoning designation amendment corrects the error noted in the zoning designation of the subject property (1570 McTavish Street) to maintain consistent regulation in the properties located within the Exhibition Grounds Master Plan.

PUBLIC INSPECTION – A copy of the proposed bylaw will be available for examination on the City's website, commencing **Friday, March 15, 2024**.

PUBLIC HEARING – City Council will hold a public hearing in relation to the proposed bylaw amendments on **Wednesday, March 20, 2024**, at 1:00 p.m. Citizens who want to address **City Council** may attend the meeting via teleconference or in person.
